

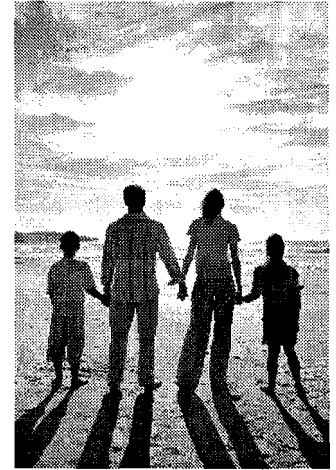


OUR MISSION:

Guide-By-Your-Side (GBYS)

Do you know a family that could benefit from direct parent to parent support from an experienced parent of a deaf or hard of hearing child? The Guide-By-Your-Side (GBYS) program is affiliated with the National H&V organization and offers parent support throughout early hearing detection and intervention years, at times of important transition or on demand as families feel the need for support. Parent Guides are able to bring their direct experience, specialized knowledge, and personal compassion to their role while making the family's needs their prime agenda. GBYS Parent Guides offer:

- * Timely emotional support at the time of screening and/ or confirmation of hearing loss
- * Direct parent/ peer support and networking
- * Information and resource sharing specific to deaf/ hard of hearing issues including insights on navigating the systems from a parent perspective
- * Support to families throughout the early intervention years by combining an experienced parent's insight with knowledge of early intervention and educational systems
- * Continuity of support to families throughout a child's life, especially at times of transitions.

Kylie Sharp and Sonya Adams just returned from the National H&V conference in Breckenridge, CO. What an event! Look forward to an article in the Fall newsletter, recapping their experiences. It's clear that H&V is a strong leader in supporting families with children who are deaf or hard of hearing. In the USA, H&V now has 19 approved state chapters, and 17 provisional state start-up chapters! They have also expanded internationally by their approved chapter in British Columbia, Canada and a provisional start-up chapter in the Philippines. Other countries have expressed a keen interest in starting their own chapters, including South Africa, Italy and the Commonwealth of Northern Mariana Islands.
